# Conditions of Booking

## Arrival and Departure Times

We will endeavour to make the property ready for 3 pm, but sometimes this will not be possible until later. (For late arrivals after 5 pm please make arrangements) Return the keys to our office no later than 10:30am.

## Key Return

Your key must be returned immediately following departure.

## Linen

Where linen is supplied please look after it. Where it is not supplied then please use appropriate linen so as not to mark the beds or protectors.

## Disturbances

**No noise between 11pm and 8am**, and do not disturb others in any way.

## Parking

No parking in the road on the chalet site. Always park according to the local conditions and restrictions. Please drive carefully and obey the speed limit. Parking is at your own risk no responsibility will be held by Windrush Holidays for any loss or damage incurred.

If you are using a commercial vehicle, permission is required.

## Rubbish

Rubbish is to be disposed of appropriately. For the chalets please put rubbish in black bags and place in bins around the site. For caravans please put rubbish in black bags and place in bins behind the launderette.

## Smoking

Smoking is not allowed in any of these properties.

## Pets and Other Restrictions

Pets are allowed in some properties by prior arrangement. Only well behaved pets are allowed. There will be a charge for pets, do not leave them on their own in the property. No pets in bedrooms or on any furniture. Pets must be kept on a lead on the site. Please do not bring noisy pets; do not let your pet foul any part of the property or grounds. Please ensure pets bring no living creatures with them.

No firearms, gun, airgun etc allowed in the property. No parties please. Any items left behind will be removed and stored for 28 days and then disposed of. Food and perishables will be disposed of immediately. You will need to send postage & handling fee before we can return any item.

## Occupants

Only those named on the booking form can use the property and any facilities.

## Damages, Breakages and Shortages etc

Please do not iron on beds or beddings. Guests will be held responsible for all damages, shortages and breakages etc. Where applicable any damages monies will be returned or cheque shredded, if no claim has been made, within 10 days of receipt of keys.

## Washing of Clothes

Only hang clothes where you are allowed. Defined in local restrictions.

## Barbeques

Barbeques can only be used by adults and at their own risk. Do not use any surface other than the designated area or rough ground. Do not move it when it is hot. Do not use liquid to light it. Do not touch any part when it is hot. Please avoid smoke etc from blowing into any window or door. Please ensure it is clean when you vacate the property. Disposable barbeques get very hot on the base and will scorch anything they rest on.

## Bunk Beds

The minimum age for children using bunk beds are; 3 years for the bottom and 6 years for the top.

## Young Persons

Bookings cannot be accepted from young persons less than 21 years of age. No persons under the age of 21 years can occupy the property unless part of a family. Keys will not be issued, even in case of prior payment.

## Specific Property or Site Rules/Conditions

Any rules of the property and/or site must also be adhered to.

## Special Requirements

Please advise us in writing when making your booking. Whilst every effort will be made to meet your specific requests, we cannot guarantee to do so in all circumstances. We cannot guarantee any feature or facility shown in the brochures to be available for use on arrival; no compensation will be liable for any facility, or equipment that is closed or not usable.

## Cancellation by Us

Very rarely, we may find it necessary to cancel holidays and we must reserve the right to do so. However, we will only cancel holidays if you fail to make payment in full and on time, or if we are forced to do so because of unusual and unforeseeable circumstances beyond our control. We regret, however, that we cannot pay any compensation or be responsible for any costs or expenses you may incur.

## Cancellation by you

We need to know at the earliest possible time if you are cancelling. We do not insure you or us for any cancellations and the only compensation we can offer is if we manage to rebook the property. We may be able to return some of your monies minus all of our costs incurred. We reserve the right to decide this on the merit of each case; our decision will be fair and final.

## Complaints

We sincerely hope you will not encounter any problems during your holiday. In the unlikely event that you do, you must notify us immediately. Most problems are capable of a quick solution and we will do our best to ensure that they are rectified. However, should you remain unhappy you must put any unresolved complaints in writing within 28 days of the end of your holiday? We will then investigate the matter and if possible, an amicable resolution will be reached. We regret that we cannot accept liability for any claim not notified to us in accordance with these booking conditions.

## Liability

No liability shall be attached to Windrush Holidays in respect of any loss or damage or injury suffered by you or any other person occupying the accommodation booked by you otherwise than due to the negligence of Windrush Holidays.

## Breaches

Any breach of any part of these conditions will incur a charge and in some cases a requirement to vacate the property and grounds immediately with no refund or compensation. The management's decision will be final.
